



















































































- ⇒ Sixty-one percent of Wisconsin's salon businesses are owned by women, compared to only 27 percent of businesses in the state's overall private sector.
- ⇒ Sixteen percent of businesses in Wisconsin's salon industry are Black or African-American-owned, versus just 3 percent of total private sector businesses.




